POSITION OBJECTIVES

Provide safe navigation and pilotage of vessels transiting the Port of Darwin to meet the operational needs of the company whilst maintaining the highest standards of safety. Provide relevant local knowledge of marine and port conditions, expertise and advice to visiting vessels and internal and external stakeholders as required.

MAIN DUTIES/KEY ACCOUNTABILITIES

- Conduct safe and efficient pilotage of vessels in the Port of Darwin, that meets the operational needs of the company, in accordance with the Technical and Safety Standards for Pilotage and the Provision of Pilotage Services – Port of Darwin (the Pilotage Standards).
- Ensure that all ships are navigated according to approved Passage Plans appropriate to the local conditions of the Port of Darwin.
- Demonstrate expertise in leadership and communication during Master/Pilot Exchange.
- Be a subject matter expert for any pilotage matters within the port, relevant to experience and current MPL level.
- Direct tug masters where appropriate to support marine navigation activities within the Port of Darwin.
- Provide visiting vessels with local knowledge specific to the Port of Darwin and the needs of the vessel.
- Liaise with ships' masters, operators, agents, regulatory bodies and providers of marine services concerning shipping in the port.
- Work collaboratively with all internal and external stakeholders to maintain effective operations of Darwin Port.
- Pro-actively undertake all safety, marine, environmental, emergency and other work-related training to meet the job requirements and needs of Darwin Port.
- Contribute effectively to Darwin Port pilotage management activities and complete all necessary non-piloting and administrative functions to assist in the day-to-day activities of the port.
- Take responsibility for ongoing training and currency compliance for the maintenance of your marine pilot licence in accordance with the pilotage standards.
- Actively participate in the ongoing day-to-day operation and review of the Marine Safety Management System and ISPO certification.
- Ensure compliance with Standard Operating Procedures, Pilotage standards and best pilotage practices.
- Demonstrate a commitment to continuously improving the Pilotage Service of DPP including the development and implementation of initiatives to improve the working relationship with customers and stakeholders, including all Darwin Port personnel.
- On occasion you may be required to be contactable outside of your ordinary hours of work.
- Contribute positively to continuous improvement activities and initiatives at Darwin Port
- Other duties as directed by your manager from time to time
