Instruction

In accordance with the Darwin Port Maritime Security Plan, the attached map shows the Port Security Zones that will be activated whilst the **Bulk Liquid** ship '**Orion Spirit**' is alongside at **Bladin Point**.

Landside Restricted Zone (LRZ's)

The Active Landside Security Zone is **ILNGL01** and will be activated by **INPEX** 30 minutes prior to arrival on **Sunday the 28th of April** until 30 minutes after the vessel departs. It is indicated in **Red**.

Maritime Security Identification Cards (MSIC's) must be worn and displayed by all persons inside the Active LSRZ. If non MSIC holders wish to enter the zone they must be escorted by an MSIC holder

Waterside Restricted Zone (WRZ's)

3The Active Waterside Security Zone is **ILNGW01** and is active from **08:00 on Sunday the 28th of April** until 30 minutes after the vessel departs. It is indicated in **Blue**.

Maritime Security Identification Cards (MSIC's) must be worn and displayed by all persons inside the Active WSRZ. If non MSIC holders wish to enter the zone they must be escorted by an MSIC holder.

Waterside Patrols will be undertaken by Darwin Port vessels whilst the area is active.

Safety

Appropriate PPE must be worn at all times.

All non-essential vehicles must vacate the wharf deck by – N/A

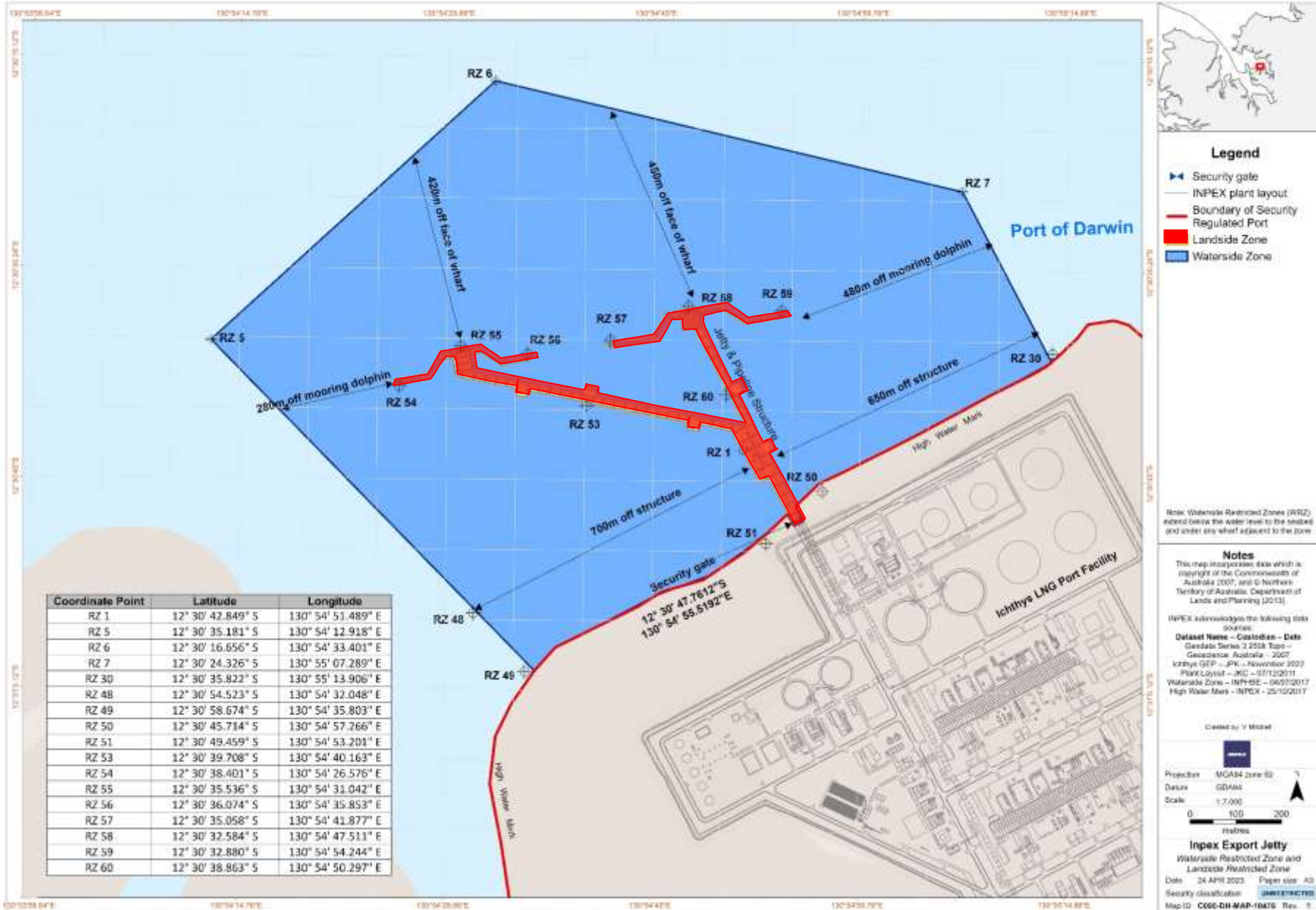
